- (1) Groups:
  - a. Group 100 is defined as Carrier’s gathering points in Lea County, NM.
  - b. Group 200 is defined as Carrier’s gathering points in Reeves County, TX.
- (2) Carrier shall have the right to deduct and retain one tenth of one percent (0.1%) of the barrels tendered for transportation hereunder to cover evaporation, interface losses and other normal losses during transportation from the Receipt Point(s) to the Delivery Point(s).
- (3) For purposes of determining which rate tier applies to Barrels delivered to the Receipt Points during such month, Carrier shall use the total of all Barrels of Crude Oil delivered to all Receipt Points during such month.
- (4) Rates are cumulative for transportation that extends through multiple paths across the Pipeline.

- (5) All charges and rates set forth in this Tariff are subject to adjustment each July 1 in accordance with the Indexing rules in 18 C.F.R. Section 342.3 or any successor methodology adopted by the Federal Energy Regulatory Commission.
- (6) When Carrier's Pipeline is in prorationing, a Committed Shipper may elect to pay a Priority Service Rate that is one cent (\$0.01) per barrel higher than the otherwise applicable rate in order to receive Priority Service under Rule 13.A.1 of the rules and regulations in Carrier's F.E.R.C. No. 1.0.0, supplements thereto and successive issues thereof.

**Material Transfer Charge**

In addition to the transportation rate set forth above, a material transfer charge of \$.10 per barrel shall apply to Crude Oil received into or delivered out of Carrier's facilities by truck.
