

# **NATIONWIDE CONNECTIVITY**

Energy Transfer LP (NYSE: ET) is a publicly traded, investment-grade limited partnership with a fully-integrated portfolio that enhances its ability to offer a wide range of services to both domestic and international markets. It owns and operates more than 130,000 miles of pipeline and associated infrastructure in 44 states, with a strategic footprint in all of the major U.S. production basins.

### A DIVERSIFIED PORTFOLIO

Energy Transfer owns and operates one of the largest and most diversified portfolios of energy assets in the United States. Its core operations include complementary natural gas midstream, intrastate and interstate transportation and storage assets; crude oil, NGL and refined product transportation and terminalling assets and NGL fractionation.

Energy Transfer also owns the general partner interest, the incentive distribution rights and approximately 21% of the outstanding common units of Sunoco LP (NYSE: SUN), and the general partner interests with approximately 39% of the outstanding common units of USA Compression Partners, LP (NYSE: USAC).

## A HISTORY OF GROWTH

Formed in 1996 as a small intrastate natural gas pipeline operator, the partnership has successfully grown through organic expansion projects and the acquisition of ~30 companies.




